## Position paper on the results of CERIS CBRN session 4th May, 2022, Lille, France

The Community for European Research and Innovation for Security (CERIS) organised a CBRN session on May 4, 2022 at the CBRNe Research & Innovation conference in Lille, France. The session opened with state-of-the-art presentations by representatives of DG HOME, DG ECHO and FPI, and continued with two panel discussions of thirteen current EU-funded CBRN projects - eNOTICE, INCLUDING, NO-FEAR, FIRE-IN, PROACTIVE, HoloZcan, ECCOFEX, RESIST, VERTIGO, JA TERROR, Bullseye, EU-RADION and PANDEM-2. The key points, take-away messages and recommendations on CBRN R&D&I can be found in the Position paper

#### Vyškov, Czech Republic, November 22-26, 2021 Host – JCBRND COE

This regular, NATO approved residential course at the JCBRN Defence COE in Vyskov was held from 22 November to 26 November 2021. The CBRN Consequence Management Course was designed to introduce and describe key elements of CBRN consequence management, focusing on first response and consequence management after a CBRN incident. The interactive training in the field of CBRN defence was included by organizing syndicate related tasks on CBRN consequence management with a focus to help to identify gaps in current capabilities and operations planning with the Learning Objectives:




- Principal NATO Consequence Management bodies, systems, procedures, NATO Consequence Management process;
  - Explain Consequence Management after CHEM incident;
  - Explain Consequence Management after BIO incident;
  - Explain Consequence Management after RAD/NUC incident;
- Lessons Learned from NATO commitments and exercises; importance of Rules of Engagement, Process and Public Information during implementation of Crisis Response Operations.

#### Warsaw, Poland, November 16-17, 2021, Host - WSU and CNBOP-PIB

The exercises Patrol-21 took place in Poland on November 15-18, 2021. The main goal of the Patrol-21 JA was to improve the procedures for launching the National Warning and Reporting System in Poland, using various scenarios of crisis situations, developing assessment, expert analysis and recommendations for further proceedings in crisis situations. The training checked:

- contamination detection system,
- · activities of non-military structures,
- IT system,
- Information system.

Testing the operation of the National Warning and Reporting System is a cyclical task that results from the regulation of the Polish government on contamination detection and notification system.

In the PATROL-21 JA participated: fire brigades, police, medical rescue, the CBRN Area Control Centre of the Polish Armed Forces, the Provincial Inspectorate for Environmental Protection in Warsaw, and the local authorities. The operation of Polish National Warning and Reporting System was checked in 17 locations in Poland (3 locations - multidisciplinary field exercise, the mazowieckie (Kanie), kujawsko-pomorskie (Toruń) and warmińsko-mazurskie (Giżycko) provinces.

#### Campus Vesta, Ranst, Belgium, May 21, 2022 Host – VESTA

The field exercise had a double purpose, training and examination, each with their own objectives and evalution criteria:

- 1. Training goals for all participating first response disciplines and players:
- Diversed training objectives, defined by each participating discipline for their own staff (monodisciplinary)
- Multidisciplinary aspects: coordination, communication, information flows, cooperation, interoperability, etc.
- ⇒ Evaluation criteria were defined per discipline.
- 2. Examination for the participants of the Postgraduate Disaster Management Course:
- Multiple students involved
- Objectives vary, every participant has a specific role and dedicated tasks, such as: play the role of leading officiers on the field, play the role of decision makers in the operational command center, play the role of diverse functions in the strategic coordination center chaired by the Mayor (student).

#### Dortmund, Germany, May 7, 2022, Host - FDDO

Full scale field exercise on 7 May 2022 had the following objectives:

- The aim of the exercise is the training of large scale events with hazardous substances
- The field exercises will be held in Dortmund. The venue will set up inspiring background for detection and identification procedures, as well as decontamination.
- Improvement of coping capacity of different units concerning their tasks
- Test and improve operating procedures of first intervention, HazMat containment, decontamination and casualty treatment
- Training of decontamination of vulnerable people (decontamination unit of FDDO)
- Training of reconnaissance using aerial systems (communication unit of FDDO)
- Training of critical situation (psychological care unit of FDDO)

#### Collaboration with H2020 project PROACTIVE

eNOTICE project collaborates with H2020 project <u>PROACTIVE</u> – PReparedness against CBRNE threats through cOmmon Approaches between security praCTItioners and the VulnerablE civil society.

PROACTIVE aims to enhance societal CBRN preparedness by increasing practitioner effectiveness in managing large, diverse groups of people in a CBRN environment. The interaction of CBRN first responders and civil population, including vulnerable groups (such as older persons, minors, persons with disabilities, etc.) during CBRN response is a key aspect that is tested at three joint field exercises organised at eNOTICE training centres in Germany, Italy and Belgium.

For eNOTICE training centres this collaboration is strategic because it allows to show to the stakeholders that the training centres of the network are open for research activities of the current R&D projects. The challenge is that training centres very seldom or some never did any exercises with real volunteers from the public. The volunteers recruited for the exercises by PROACTIVE project partly belong to vulnerable groups of population, which presents a big challenge for the first responders, prompting them how to interact with real people (not actors!) in a real crisis situation.

One Joint Activity of eNOTICE and PROACTIVE has been successfully completed in Dortmund, Germany, on May 7, 2022.
